# a) Cactus Channel Improvement Project – Grant Funding Update

Mathew Evans, Planning Director, March JPA provided an update on this item. Member Lee stated that some grant support letters from stake holders would be helpful. Mr. Evans stated that the grant application required JPA to get a letter of support from the base command, which they did and that was all they asked for. Mr. Evans added that he thinks that is a great idea and he will reach out to all member agencies and asked for letters of support for future grants.

Thomas Rice, BB&K, March JPA Legal Counsel stated that at the last Joint Powers Commission meeting the Commissioners adopted a resolution to authorize staff to seek grants for the Cactus Channel project without prior Commission approval - an ask for forgiveness rather than permission resolution.

# b) Truck Route Ordinance

Lauren Sotelo, Senior Planner, March JPA provided an update on this item.

Member Phung asked if the JPA is following the same path on code violation fees as other jurisdictions. Ms. Sotelo answered that the monetary fine schedule was identified in the presentation and staff report as a mitigation measure within the South Campus EIR. JPA is following those guidelines from the MMRP. Chair Rodriguez asked if there was anything to measure the mileage just to get an idea of what the overall cost would be. Ms. Sotelo answered yes, the Sheriff's department has a mileage rate of .56 per mile in addition to their hourly rate versus the CHP which three months is almost \$50,000. It would be cheaper to go with the Sheriff's department since we already have a contract with them.

# Background:

Colonel Rodney E. McCraine is the Commander of the 452d Mission Support Group at the March Air Reserve Base. He leads more than 1,400 Citizen Airmen in five squadrons and three functional areas who provide peacetime and wartime mission readiness support for the Air Force Reserve Command and Air Mobility Command. The 452d MSG provides security, communications, logistics, personnel management, and information management programs for 3,400 Reserve and civilian personnel.

Col. McCraine is the lead Commander of development services on the Base and oversees operations at the Base Civil Engineer's office – an office that helps the Authority review private developments around the Base. Staff has requested that Col. McCraine attend the Technical Advisory Committee meeting to introduce himself and speak about the current missions at March ARB. Moreover, as the Authority is proceeding with sunset planning efforts, Col. McCraine will be presenting key Base projects that the Authority should be aware of going forward.

This is a good opportunity for the TAC to ask any questions they may have regarding March ARB. Col McCraine will be presenting at the October 27<sup>th</sup> Joint Powers Commission meeting.

Sunsetting of the March Joint Powers Authority

## Background:

At the August 5th, 2021, Special TAC meeting it was recommended that staff solicit proposals from certain consultants to assess the Authority territory, along with its associated assets and liabilities, and present recommendations for a Sunset Plan. Staff received proposals from three consultants - RSG Inc.; David Taussig Associates; and Kosmont Companies. While their scopes of work and costs of services varied, RSG Inc. was selected to help Staff with the first phase of sunset planning discussions.

RSG Inc., in coordination with BB&K, Urban Futures and JPA staff, will present several Sunset Plan options for the Authority. The presentation is intended to provide high level data that staff will utilize on October 13<sup>th</sup> to seek guidance from the Commission on their vision, priorities and goals for winding down the MJPA. With the Commission selecting a preferred Sunset approach for the MJPA, their direction will help guide staff's subsequent planning efforts with the TAC.
