### 1. Call to Order

Chair Hewitt called the meeting to order at 9:15 a.m. Roll Call - Present: Chair Hewitt, Vice Chair Conder, Member Vargas

# 3. Approval of Minutes of the Finance Subcommittee Meeting held on January 13, 2022

### 4. Report/Discussion/Action-All Agencies:

Discussion: Three Year Budgets – All Agencies

Member Vargas asked if there was an offer on the table for Green Acres. Dr. Martin answered yes, there is an offer that will be discussed at the next JPC meeting.

Member Vargas asked what the plan is for the street at the museum. Dr. Martin answered that they are working on it. The museum used to receive water runoff from the nearby freeway and Hillwood is installing a channel that will address that drainage. The museum staff is working closely with Hillwood to make sure the grading doesn't impact museum access.

Chair Hewitt asked about the airport loan. Mr. Beltran, March JPA Finance Consultant answered that the total of the loans is \$4.6 million and added that of the \$4.6 million, \$597,000 of the loans have zero-interest. Chair Hewitt asked to clarify a plan for loan payoff. Mr. Beltran responded that a 3-year payment plan would equal \$1.5 million per year. Member Vargas asked about loan forgiveness. Mr. Beltran reported that going in to 2022/23 the airport budget will be \$331,722 in the negative. In 2021 it was \$1.8 million in the negative while at the end of 2021/22 that number dropped to \$1.5 million. Today, the airport deficit is at \$331,000. Mr. Beltran added that they are looking at eliminating the negative through careful planning. Vice Chair Conder asked if Dr. Martin remembers what the loans were used for. Dr. Martin stated the JPA has loaned the airport funds since 2004 to support operations and to build the terminal. Member Vargas asked when Dr. Martin plans on bringing the item to the Commission. Dr. Martin responded that it would be on the next Commission's agenda. Member Vargas asked committee members if they would recommend forgiving the loan. Chair Conder supported the forgiveness of loans while Chair Hewitt stated that he needed to think about it more. Chair Hewitt recommended that the Commission consider different approaches on the loan, including loan forgiveness.
