#### 1. Call to Order

Chair Conder called the meeting to order at 2:59 p.m.

#### 2. Roll Call

#### 5. Report/Discussion/Action – All Agencies:

Discussions: Annual Audit Review – All Agencies Scott Manno, RAMS provided the annual audit review.

Chair Conder asked Dr. Martin if the final numbers in the audit report for the net position included the payment received for land sales. Dr. Martin answered no, those have not yet hit the books.

Chair Conder stated that this is a receive and file report and asked Dr. Martin if the report will be taken to the commission at the June meeting. Dr. Martin answered, yes.

Mr. Beltran stated that the audit incorporated a new pronouncement for leases. Leases have always existed in the organization, but the long-term liability had not been previously recorded because it wasn't required. However, in FY 2021-22, this became a requirement in the audit.

Chair Conder asked if everything JPA owned is fully leased out and also inquired about the property that was on fire. Dr. Martin stated that barracks in the northeast corner are vacant buildings and staff is experiencing transient issues in those buildings.

Vice Chair Vargas asked where they are at with Pyro Spectacular. Dr. Martin stated that they are all caught up with their rent and they will be off the property sometime this summer. However, as JPA no longer owned the upper plateau that lease was taken over by the developer.

#### **Airport Investment Account**

Steven Spare and Dick McDonald with Citizens Trust provided an update on this item.

Chair Conder asked when it is anticipated that the investment would start for the airport. Dr. Martin responded that the hope is to start an investment fund this year for the airport. There was formerly owned airport land sold last fiscal year for \$4 million. Investing \$2 million of that revenue would allow a return on investment for the airport.

Dr. Martin stated that this month the JPA began receiving revenues from an airport ground lease agreement with Hillwood on parcel D-2. She added that JPA anticipates that the ground lease would generate at least \$2 million annually for the airport.

Vice Chair Vargas asked if Target was all ground operations, not air. Dr. Martin responded 'that's correct'.

#### **Economic Impact Analysis Report**

Dr. Qisheng Pan provided an update on this item.

Dr. Pan reported that the current jobs impact would be 14,195 while indirect jobs would be about 9,851. Chair Conder asked what the indirect jobs are. Dr. Pan responded that those included over five thousand jobs in LA county. Chair Conder commented that that study has a lot of good numbers on March JPA area contribution to the local economy. Southern California benefit of \$14 billion is pretty amazing. Dr. Martin stated that in 2016 the base also did their own economic impact assessment, completed by Claremont College, and at that time their methodology was very different. She added that Dr. Pan was brought in because he has done a lot of work with SCAG (Southern California Association of Governments). He was able to bring in SCAG information which reflects the overall regional impact for the area. Dr. Martin added that Colonel Aufderheide is interested in updating the base's numbers so one of the actions that will be brought to the commission is requesting an amendment to Dr. Pan's scope of work so the JPA can incorporate the March ARB numbers in the study for an overall March area study.
