Furthermore, in the draft Environmental Justice Element being considered by the March JPA, policies HC 15.1 and 15.2 encourage coordination and collaboration with community organizations and community members when promoting participation in environmental justice and planning. Therefore, we respectfully request that any planning for the park required under the 2003 Settlement Agreement, and as required by your (as yet unadopted) EJ policies, include formal participation by members of the community, including but not limited to youth/adult sports leagues, mountain bikers, hikers, and other interested parties. That may take the form of a Community Advisory Board, as R-NOW has suggested, or some other formal mechanism to be determined with community input.
