The CITIES OF MORENO VALLEY, a general law city of the State of California, PERRIS, a general law city of the State of California, and RIVERSIDE, a charter city and municipal corporation of the State of California, Cities, and the COUNTY OF RIVERSIDE, a political subdivision of the State of California, County, do hereby agree on this 200 day of Falloway, 1974, to amend that certain Joint Powers Agreement between Caties and County for the Formation of a Joint Powers Authority to Formulate and Implement Plans for the Use and Reuse of March Air Force Base dated September 7, 1993, as follows:

1. The first sentence of Section 5(d) of the Joint Powers Agreement is changed to read:

"The presence of five (5) Members of the JPC shall constitute a quorum of which at least four (4) Members shall represent each Party to this Agreement, provided, however, that there shall be no requirement for the presence of four (4) Members representing each Party if both Members of the Party are absent for two (2) successive meetings."

- 2. All other provisions of the Joint Powers Agreement remain the same.
- 3. This First Amendment to the Joint Powers Agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together, shall constitute one and the same instrument.
