

1 **SECOND AMENDMENT TO JOINT POWERS AGREEMENT**
2 **CREATING THE MARCH JOINT POWERS AUTHORITY**

3 The CITIES OF MORENO VALLEY, a general law city of the State
4 of California, PERRIS, a general law city of the State of California,
5 and RIVERSIDE, a charter city and municipal corporation of the State of
6 California, Cities, and the COUNTY OF RIVERSIDE, a political subdivision
7 of the State of California, County, do hereby agree on this 28th day of
8 February, 1994, to amend that certain Joint Powers Agreement
9 between Cities and County for the Formation of a Joint Powers Agreement
10 to Formulate and Implement Plans for the Use and Reuse of March Air
11 Force Base dated September 7, 1993, as follows:

13 1. The last unnumbered paragraph in Section 5(j) of the Joint
14 Powers Agreement is changed to read:

15 "The JPC may request the Parties to this Agreement
16 to contribute funds; provided, however, that any
17 such contribution shall be on an equal basis as
18 among the Parties unless such request by unanimous
19 vote of all the Members of the JPC provides
20 otherwise. Such funds may not be assessed or
21 collected unless the governing body of each Party
22 to this Agreement consents thereto.

23 2. Section 5(j) of the Joint Powers Agreement is changed by
24 adding an unnumbered paragraph at the end thereof to read:

25 "Any revenue, rents, profits or issues derived by,
26 or on behalf of, the JPC other than grants,
27 donations and "in kind" contributions from the
28 Parties to this Agreement and which are not
required to implement and carry out the purposes of
this Agreement, shall be shared and distributed
equally to the Parties of this Agreement unless
otherwise as directed by a unanimous vote of all
the Members of the JPC."

1 3. The first sentence of the second unnumbered paragraph of
2 Section 7 of the Joint Powers Agreement is changed to read:

3 "It is the intent of the Parties that, except as
4 provided herein, the JPC cannot incur any debts,
5 liabilities or obligations without the consent of
6 the governing body of each Party to the Agreement;
7 provided, however, any such debts, liabilities or
8 obligations shall be shared, and otherwise
9 apportioned, equally as among the Parties to this
10 Agreement unless the JPC by unanimous vote of all
11 the Members of the JPC directs otherwise.

12 4. All other provisions of their Agreement remain the same.

13 5. This Second Amendment to the Joint Powers Agreement may be
14 executed in multiple counterparts, each of which shall be deemed an

1 original, but all of which together, shall constitute one and the same
2 instrument.

4 Agreement to be executed and attested by their proper officers thereunto
5 duly authorized as of the date first above written.
