1. Fiscal Year 2026-27 Budget Review Discussion

Jonathan Foster provided a status update for audit report preparations for Fiscal Year 2024-25. Report preparations are in progress.

Dr. Martin presented the Fiscal Year 2026–27 budget, which was adopted by the JPC at its December 17, 2025, meeting. The proposed budget adjustments were based on budget performance during Fiscal Year 2025–26. The Subcommittee concurred with incorporating investment fund maturity earnings into the revenue projections. Bank fees were discussed and will be researched further. Capital projects will need updating as the OLDCC (Office of Local Defense Community Cooperation) is a new grant. Along with a new phase of the apron project coming online.

A recently submitted invoice from March ARB, pursuant to an MOA with MIPAA, was reviewed and discussed. MARB received comments from staff and is updating the invoice. Dr. Martin shared that at the next JPC Meeting Staff will request to work with the 163d Air National Guard (ANG) on a Military Construction Cooperative Agreement for ANG facilities located at March Air Reserve Base.
